









Working Together to Address Acute Water Challenges: Water-Related Collective Action in California and the Colorado River Basin

Overview

This convening will explore how collaboration among private, public, and civil society sectors can help address the range of water challenges facing water scarcity and drought in the Southwestern United States. It seeks to bring a face-to face dimension to efforts already underway through the CEO Water Mandate's Water Action Hub, an online platform built to help facilitate collective action. It will canvas the range of water-related challenges facing the region with a particular focus on the drought conditions facing much of the Western United States, and discuss the range of multi-stakeholder collaborative activities underway to address these challenges. The convening will have an "action-focused" dimension bringing interested parties together to identify possible areas for short and long-term coordination and action.

The morning sessions will have two purposes: to provide context for the array of identified water challenges facing the region and to showcase some initiatives underway (involving business) to address these challenges.
